 - to meet the requirement of the statutory guidance on the Constitution Regulations to publish information about their members
 - to meet the duty to publish their register of interests
- Academies:
 - to meet the requirement set out in the Financial Handbook

Key:

Name = Name of governor / trustee / associate member

Category = Type of Governor

Term = Current term of office as a governor / trustee / associate member at the school/academy

Position = Named individual role/s ie. Chairman

Committees = List the committees on which the governor / trustee / associate member sits and whether or not they have voting rights.

Business Interests = Declare any directorship/partnership/employment with any businesses providing goods or services to the school/trust. Also declare any trusteeship/governorship at other educational institutions or charities, regardless of whether there is a trading relationship with the school/academy.

Nature of Business = Self-explanatory

Dates of Interest = The date on which interest began

Personal Interests = Declare any 'connected persons', which include a spouse/unmarried civil partner/children/siblings/grandchildren/grandparents or businesses where a 'connected person' is a director/partner/shareholder/employee which could be seen to prevent the trustee/governor/ associate member from making a decision in the best interests of the school. A conflict of interest is any situation in which a trustee/governor's personal interests or loyalties to another person or organisation could be seen to prevent a decision being made in the best interests of the school/academy.

NB: *It is the responsibility of individual governors/trustees/ associate members to inform the relevant person at the school/academy of any changes in their business or personal interests so this grid can be amended accordingly and the dated.*

If in doubt, declare!
